Scott--Aimee in our office has forwarded your email concerning safety. The NDA Drilling Safety Guide was a collaborative effort of member delegations of the Diamond Core Drill Manufacturers Association (DCDMA), the National Drilling Association (NDA) and the National Ground Water Association - Drill Rig/Heavy Equipment Product Group and Safety Subcommittee (NGWA). This guide contains suggested safety procedures that represent the collective knowledge of the members representing the named groups.

A similar process is utilized for the development of all the safety related materials produced by NDA. This includes the NDA Safety Label Kits, Tailgate Safety Topics and the soon to be released NDA Drilling Safety Video. NDA has received positive feedback from the National Highway Institute/Federal Highway Administration and the Remediation Safety Team Drilling Safety Subcommittee group that includes companies such as BP, ChevronTexaco, ConocoPhillips, ExxonMobil, Shell and URS. NHI/FHWA will use the NDA Drilling Safety Guide and the NDA Drilling Safety Video for their training course that will be introduced in 2006. The Remediation Safety Team Drilling Safety Subcommittee are publishing an environmental drilling safety guidance document that will include sections of the NDA Drilling Safety Guide. So it would appear that our efforts have gained favorable approval from some key industry groups.

I might also mention something that may be of interest to you in your efforts manage risk by driving down injury/accident rates. NDA has formed a task force form an alternative insurance market program for members with the goal of providing more complete coverage forms and lower net costs through risk management systems not available through commercial insurance carriers. The program will be launched in early 2006. A captive insurance workshop has been scheduled for September 21st in Pittsburgh and I can provide details if you would be interested in attending to hear first hand how the program will work and learn the difference between managing your risk instead of just buying insurance.

I hope that this information addresses your questions. The NDA Safety and Training Committee are quite active in developing materials and programs for members. You may want to consider joining NDA and participating directly in these efforts. If I can be of an further assistance please do not hesitate to ask.

I have just partially reviewed the subject document, and find it difficult to comprehend why you make a statement "Drilling activities are inherently dangerous..." (Paragraph 1.3, p15). I cannot imagine how much liability this statement adds to your manufacturing membership. Every time there is a product liability, or other liability, case, the plaintiff will bring this document to the court, and point out that the manufacturer is providing a dangerous device, or in our case, that we are specifying the performance of "dangerous activities."

Some 22 or 23 years ago, when I was with CME, I wrote the first draft of the NDF's drilling safety guide. We believed that the equipment we were making was not "inherently dangerous" and we made every effort to assure that such language was not in the first edition of that document. I sincerely hope that something is done about this.
